Dear Secretary Bose:

In accordance with the requirements of the Interstate Commerce Act and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC"), Plantation Pipe Line Company ("Plantation") submits for filing the following tariff, effective July 1, 2020:

- FERC No. 155.27.0, Local, Proportional, and Volume Incentive Tariff (cancels FERC No. 155.26.0); and
- FERC No. 156.18.0, Joint and Volume Incentive Tariff with Marathon Pipe Line LLC (cancels FERC No. 156.17.0) and
- FERC No. 159.2.0, Committed Rate Tariff (cancels FERC No. 159.1.0)

Plantation is making this filing in compliance with 18 CFR § 342.3, Indexing. The attached table of Tariff Schedule Changes contains the information required by 18 CFR § 342.3(b), including the rate schedule to be changed, the proposed new rates, the prior rates, the prior ceiling level, and the applicable ceiling level for the movement from July 1, 2020 to June 30, 2021 . All tariff rates in FERC No. 155.27.0 are increased unless otherwise noted.

FERC No. 156.18.0 is a joint tariff with Marathon Pipe Line LLC. As shown in the attached Joint Rate Justification Table, the joint rates are equal to the sum of the local rates on file with the FERC in Marathon's FERC No. 302.12.0 and Plantation's FERC No. 155.27.0. All rates in Item 10 of FERC No. 156.18.0 are increased. The contact person at Marathon Pipe Line LLC is Shelley Purser Peebles, Tariff Coordinator. FERC No. 159.2.0 is a Committed Rate that applies to the movement by committed shippers on a portion of the expansion capacity between Collins, MS and Greensboro, NC. This expansion capacity is associated with the Petition for Declaratory Order approved on April 12, 2019 in Docket No. OR19-12-000. All tariff rates in FERC No. 159.2.0 are increased unless otherwise noted.
