Dear Secretary Reese:

In accordance with the requirements of the Interstate Commerce Act and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC"), Hiland Crude, LLC ("Hiland") submits for filing the following tariffs, effective January 1, 2025:

- FERC Tariff No. 3.20.0, Proportional Tariff applying on the gathering / transportation of crude petroleum on the Tioga Gathering System (cancels FERC No. 3.19.0);
- FERC Tariff No. 4.18.0, Proportional Tariff applying on the gathering / transportation of crude petroleum on the Richland County Gathering System (cancels FERC No. 4.17.0); and
- FERC Tariff No. 5.43.0, Proportional Tariff applying on the gathering / transportation of crude petroleum on the Market Center Gathering System (cancels FERC No. 5.42.0).

In compliance with 18 C.F.R. § 341.3, Hiland submits FERC Tariff Nos. 4.18.0 and 5.43.0 establishing new gathering discounts for all shippers that reach certain tier levels for barrels delivered to the Market Center and Richland County Gathering Systems. Hiland is providing the additional gathering discounts to incentivize its shippers to continue to transport volumes on Hiland's Gathering Systems on recently executed contracts. All rates in FERC Nos. 3.20.0, 4.18.0 and 5.43.0 are unchanged from the prior tariffs

Also, Hiland submits FERC Tariff No. 3.20.0 to revise the definition of the Tioga Gathering origin area to include Township 155N Range 95W Section 1 and Township 156N Range 95W Sections 1 and 35.

Hiland requests special permission to submit the tariffs listed above on less than thirty-days' notice under authority of 18 C.F.R. §341.14 and §341.2, to have the additional gathering discounts to be effective January 1, 2025. Hiland submits that good cause exists for granting this request. Permitting the tariffs to become effective on less than thirty days' notice will benefit Hiland's shippers because it will ensure that the tariffs will allow shippers the opportunity to nominate movements as soon as possible. Hiland acknowledges that this tariff publication is conditionally accepted subject to refund pending a thirty-day review period.
