Dear Secretary Reese:

In accordance with the requirements of the Interstate Commerce Act ("ICA") and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC" or "Commission"), Kinder Morgan Utopia LLC ("Utopia") submits for filing the following tariff ("International Joint Volume Incentive Rate Tariff"), effective September 1, 2025:

• FERC Tariff No. 7.7.0, International Joint Volume Incentive Rate Tariff applying on the transportation of purity ethane (cancels FERC Tariff No. 7.6.0)

Following indexation, Utopia became aware of an error in its calculation of rates that occurred in its October 1, 2024 tariff filings. A correction to the rates, on a prospective basis, is being filed by Utopia in FERC Tariff No. 7.7.0, to be effective September 1, 2025. Included in this filing is a table showing the Tariff Schedule Changes, which contains the information required by 18 C.F.R. § 342.3(b), including the corrected rates schedule to be changed, the proposed new rate, the prior rate, and the applicable ceiling level. The rates in FERC No. 7.7.0 are proposed in accordance with Section 342.3(a) of the Commission's regulations, which permits a carrier to change a rate, at any time, to a level which does not exceed the then-applicable ceiling level.¹

Utopia's International Joint Volume Incentive Rate Tariff has been adjusted in accordance with the applicable ceiling level. As shown in the Joint Rate Justification Table included in this filing, the sum of the local rates in FERC Tariff No. 2.5.0 and Kinder Morgan Utopia Ltd. CER No. 25, is greater than or equal to the international joint volume incentive rates.
